Article #20: Sum of \$120,000. Roger Lafleur motioned, Paul Ayers 2<sup>nd</sup>. So voted.

Article #21: Sum of \$31,000. Roger Lafleur motioned, Paul Ayers 2<sup>nd</sup>. So voted.

Article #22 and #23: \$30,000 + \$30,000. Totaling \$60,000. Paul Ayers motioned, Roger Lafleur 2<sup>nd</sup>. Robert Barnes abstained. So Voted.

Article #24: Sum of \$5500. Roger Lafleur motioned, Paul Ayers 2<sup>nd</sup>.

Article #28: 8% to 4% low income seniors on unpaid taxes. Cindy Mundell motioned, Paul Ayes 2<sup>nd</sup>. So Voted

Article #29: Police Details: No vote taken. Wait for town meeting for more information.

Article #30: Sum of money from Free Cash to Stabilization Account: No vote taken wait until town meeting for more information.

Article #31: No vote taken, more information needed from Selectman.

Discussion: Tax Levy amount is \$57,931. Free Cash is \$10,427. Robert Barnes motioned to move \$31,000. for Article #21 from the Tax Levy instead of from Free Cash. Marybeth Harrity 2<sup>nd</sup>. So voted.
