Mr. Simon began by opening the hearing for D.O.A. (Determination of Applicability), Re: James Carreia – White's Landing – Rte. 148). The only condition: any loose dirt exposed needs to be covered every night (with a tarp) so no dirt runs into river. No hay bales needed.

Mr. Cleveland motioned to vote for negative impact with conditions: Any loose dirt will be covered by tarp and Mr. Correia's plans will be attached. Mr. Neault 2<sup>nd</sup> the motion. All in favor - none abstained. Mr. Simon closed hearing at 7:30 p.m.

**OLD BUSINESS:** Forest cutting plan discussed. Conservation Commission questioning the form filled out with no follow-up. Mr. Cleveland will check with State Representative Anne Gobi. Mr. Neault is going to find out who to contact with questions.

Mr. Cleveland made a motion to accept minutes (January 25, 2011) with revisions. Mr. Neault 2<sup>nd</sup> the motion.

A list of unfinished business was discussed and the Conservation Commission will be tying up any loose ends.

Annual Report for FY 2010 was reviewed by ConComm members.

**NEW BUSINESS:** Mr. Neault announced he has a computer and will be compiling CMR information and contacts for information.

Motion made by Mr. Cleveland to adjourn meeting. Mr. Neault 2<sup>nd</sup> the motion.
