SPECIAL TOWN MEETING, DECEMBER 8, 1970

WORCESTER SS.

To either of the CONSTABLES of the Town of BROOKFIELD in the County of WORCESTER GREETING.

IN THE NAME OF The Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and in Town affairs, to meet at the Town Banquet Hall, in said Hall, on Monday, the seventh day of December next, at 8:00 o'clock in the afternoon, then and there to act on the following articles:-

Meeting opened at 8:15 P.M. -- 35 Voters present.

ARTICLE 1. To see if the Town will vote to transfer a sum of money from the WATER DEPARTMENT'S LABOR ACCOUNT to the MAINTENANCE ACCOUNT, or take any action relative thereto.

It was voted to transfer the sum of \$500.00 from the WATER DEPARTMENT'S LABOR ACCOUNT to the WATER DEPARTMENT'S MAINTENANCE ACCOUNT.

ARTICLE 2. To see if the Town will vote to transfer a sum of money from the HYDRANT ACCOUNT to the MAINTENANCE ACCOUNT, or take any action relative thereto.

It was voted to transfer the sum of \$800.00 from the WATER DEPARTMENT'S HYDRANT ACCOUNT TO THE WATER DEPARTMENT'S MAINTENANCE ACCOUNT.

ARTICLE 3. To see if the TOWN will vote to transfer \$2500.00 from AVAILABLE FUNDS in the TREASURY to the GENERAL HIGHWAY ACCOUNT, or take any action relative thereto.

It was voted to transfer the sum of \$2500.00 from available funds in the Treasury to the GENERAL HIGHWAY ACCOUNT.

Meeting adjourned at 8:28 P.M.

And you are directed to serve this Warrant, by posting up attested copies thereof at Town Hall, Post Office and Gavitt's in said Town, seven days at least before the time of holding said meeting.

HEREOF FAIL NOT, and make due return of this Warrant with your doings thereon, to the Town Clerk, at the time and place of meeting, as aforesaid.
