

SPECIAL TOWN MEETING
FEBRUARY 10, 1998 7:30 P.M.

ARTICLE 1. To see if the Town will vote to transfer a sum of money from the Highway Department Expense Account to the Snow & Ice Account, or take any action relative thereto. (Sponsored by the Highway Department).

The Town voted unanimously to transfer the sum of \$13,000.00 from the Highway Department Expense Account to the Snow & Ice Account.

ARTICLE 2. To see if the Town will vote to transfer a sum of money to the Highway Department Asset/Repair Replacement Account, or take any action relative thereto. (Sponsored by the Highway Department).

The Town voted unanimously to transfer the sum of \$709.00 from Chapter 113 to the Highway Department Asset/Repair Replacement Account.

ARTICLE 3. To see if the Town will vote to transfer a sum of money from the Septage Hauling Account to the Title V Administration Account, or take any action relative thereto. (Sponsored by the Board of Health).

The Town voted unanimously to transfer the sum of \$700.00 from the Septage Hauling Account to the Title V Administration Account.

ARTICLE 4. To see if the Town will vote to transfer a sum of money from the sale of walking tour booklets to the Historical Commission Expense Account, or take any action relative thereto. (Sponsored by the Historical Commission).

The Town voted unanimously to transfer the sum of \$40.00 from the General Insurance Account to the Historical Commission Expense Account.

ARTICLE 5. To see if the Town will vote to transfer a sum of money from the Repairs to the Fire Station Roof Account to the Fire Department Expense Account, or take any action relative thereto. (Sponsored by the Fire Department).

The Town voted unanimously to transfer the sum of \$3,824.80 from the Repairs to the Fire Station Roof Account to the Fire Department Expense Account.

ARTICLE 6. To see if the Town will vote to transfer a sum of money from the Ladder Testing and Replacement Account to the Fire Department Expense Account, or take any action relative thereto. (Sponsored by the Fire Department).

The Town voted unanimously to transfer the sum of \$2,214.00 from the Ladder Testing and Replacement Account to the Fire Department Expense Account.

ARTICLE 7. To see if the Town will vote to transfer a sum of money from the Landfill Monitor Salary Account to the Assistant Landfill Monitor Salary Account, or take any action relative thereto. (Sponsored by the Board of Health).

The Town voted by majority to transfer the sum of \$1,300.00 from the Landfill Monitor Salary Account to the Assistant Landfill Monitor Salary Account.

ARTICLE 8. To see if the Town will vote to transfer a sum of money to pay for services rendered by a former employee for snowplowing services during fiscal year 1997, or take any action relative thereto. (Sponsored by the Board of Selectmen).

The Town voted unanimously to transfer the sum of \$200.00 from the General Insurance Account to pay for services rendered by Edward Juda, a former employee, for snowplowing services during fiscal year 1997.

ARTICLE 9. To see if the Town will vote to transfer a sum of money to pay bills from a prior year, or take any action relative thereto. (Sponsored by the Town Accountant).

The Town voted unanimously to transfer the sum of \$65.00 from the Police Department Expense Account to pay two bills from a prior year: \$14.89 to AT&T and \$50.11 to Nynex.

The meeting was adjourned at 7:38 p.m. Thirty (30) people attended the meeting.
