SPECIAL TOWN ELECTION WARRANT

WORCESTER, SS:

To either of the Constables of the Town of Brookfield in the County of Worcester,

GREETINGS:

IN THE NAME OF THE COMMONWEALTH OF MASSACHUSETTS, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and in Town affairs, to meet at the Town Hall, Banquet Hall, 6 Central Street, Brookfield, MA on Monday the Twelfth day of September in the year 2005 from 7:00 a.m. to 7:00 p.m. then and there to vote on the following question and to act on the following Article:

“Shall the Town of Brookfield be allowed to exempt from the provisions of Proposition 2-1/2, so called, the amount required to pay for the bonds issued for the purpose of purchasing a new fire truck, including the payment of all other costs incidental and related thereto?”

ARTICLE 1. To elect all on one ballot the following officers: **One Moderator** for nine months; **One member of the Board of Health** for one year nine months (both to fill unexpired terms).

And you are directed to serve this warrant, by posting up attested copies thereof, at the Town Hall and Post Office in said Town, fourteen days at least before the time of the holding of said meeting.
