SPECIAL TOWN MEETING WARRANT  
FRIDAY JUNE 8, 2012**

WORCESTER, SS:

TO EITHER OF THE CONSTABLES OF THE TOWN OF BROOKFIELD IN THE COUNTY OF WORCESTER

GREETINGS:

IN THE NAME OF THE COMMONWEALTH OF MASSACHUSETTS, YOU ARE HEREBY DIRECTED TO NOTIFY AND WARN THE INHABITANTS OF SAID TOWN, QUALIFIED TO VOTE IN TOWN AFFAIRS, TO MEET AT THE **BROOKFIELD ELEMENTARY SCHOOL, 37 CENTRAL STREET, BROOKFIELD, MA ON FRIDAY, JUNE 8, 2012 at 6:15 P.M.** TO ACT ON THE FOLLOWING ARTICLES:

**ARTICLE 1:** To see if the Town will vote to transfer the sum of \$83,127 from Free Cash to the Stabilization Account, or take any action relative thereto.

**This amount was recently certified; the Selectmen and Advisory Committee promised at the last town meeting that when this amount was received that it would be put into the Stabilization Account. The Board of Selectmen and Advisory Committee unanimously support this article.**

**The Town voted unanimously to transfer the sum of \$83,127.00 from Free Cash to the Stabilization account.**

**ARTICLE 2:** To see if the Town will vote to transfer the sum of \$65.00 from available funds to Police Department Expense Account to pay a late water bill from fiscal year 2011; or take any action relative thereto. **(9 10<sup>th</sup> vote required)**

**This is a late bill which can only be paid by Town Meeting vote. The Board of Selectmen unanimously supports this article.**

**The Town voted unanimously to transfer the sum of \$65.00 from in Lieu of Taxes Account to the Police Department Expense Account.**

**ARTICLE 3:** To see if the Town will vote to transfer the following amounts of money from the listed Fund sources to Stabilization to close out the accounts or take any action relative thereto.

**This is clean-up action proposed to close out certain unused accounts with small balances.**

**The Town voted to pass over this article.**

**ARTICLE 4:** To see if the Town will vote to transfer the sum of \$4,000 from Mill Street Brownfield Account to an account to be used toward the purchase of a lawnmower and related equipment for use by the Town at Mill Station Park and other sites within the town; or take any action relative thereto.

**The Mill Street Brownfield Account was set up for research regarding this site about 2003 and there is currently a balance of about \$9,800.00. The Board of Selectmen and the Advisory Committee unanimously support this article.**

**The Town voted unanimously to transfer the sum of \$4,000.00 from the Mill Street Brownfield Account to an account to be used toward the purchase of a lawnmower and related equipment for use by the Town at Mill Station Park and other sites within the Town.**

**ARTICLE 5:** To see if the Town will vote transfer the sum of \$1,000 to be used for the purchase of a new fax machine and table top copier in the Town Hall; or take any action relative thereto.

**The Selectmen voted unanimously to support this article which will allow for the purchase of either a new fax machine and a table top copier or a combinations machine for use in the Town Hall.**

**The Town voted unanimously to transfer the sum of \$1,000.00 dollars from the General Insurance Account to be used for the purchase of a new fax machine and table top copier to be used in the Town Hall.**

**THIS WARRANT HAS A TOTAL OF 5 ARTICLES.**

**The meeting opened at 6:15 p.m. and adjourned at 6:21 p.m.**

**37 Voters attended the Special Town Meeting.**
